Continuing Student Request for I-20 for F-1 Status

This application is for any **CONTINUING** Cornell student who wants to gain F-1 student status. This may include students already at Cornell but in a different immigration status (such as H-4 or J-1), or it may include students who have been out of the U.S. for an extended time on leave of absence from Cornell. This form should not be used for students who have been newly admitted to Cornell—new admits should contact the appropriate admissions office. This is also not the form for current F-1 students to extend their I-20—for I-20 extension please see the “F-1 Student I-20 Extension” request form.

In order to qualify for an I-20, you must be admitted to Cornell as a student and be able to show proof that you have the funding to cover tuition and living expenses while at Cornell. Please complete the form and return it to an ISSO advisor.

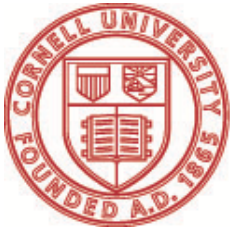

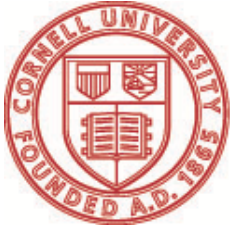

PROOF OF FINANCIAL SUPPORT:

You must provide proof that you have the financial support to pay the tuition and living expenses for three years or through the end of your program (whichever is shorter). You may provide personal bank statements, or letters of sponsorship along with the sponsor's bank statements, or letters of departmental funding such as teaching assistantship or research assistantship. The amounts required for different degree programs are attached on the "Estimated Expenses" sheet.

CHANGING VISA STATUS:

This application is for Cornell ISSO to create an I-20 for you. Once you have the I-20, you will still need to either apply for a change of status from the U.S. Citizenship and Immigration Service within the U.S., or travel out of the U.S., go to a U.S. consulate to apply for an F-1 visa stamp and then re-enter the U.S. in F-1 status. If you change your visa status within the U.S., that will give you valid F-1 status while you remain here, but the next time you travel out of the U.S., you will still have to go to a U.S. consulate to apply for an F-1 visa stamp before you can re-enter (except for short trips to Canada and Mexico).
